

Registration Policies, Agreements and Releases

- Enrollment Requirements: \$400 Registration Fee, a completed & signed Registration form, a copy of each child's immunization records, Tuition, Membership & Building Fund arrangements must be submitted to the Administration Office for registration to be considered complete.
- Additionally, enrollment is contingent upon review and approval of each child's immunization record and payment arrangement.
- Registration Fee: This is a separate charge from Tuition and is completely non-refundable.
- Building Fund Fee: This is a separate charge from Tuition and is completely non-refundable. Must be fully paid out by December 2017.
- No refunds or partial payments will be authorized for absences or incomplete attendance regardless of the reason.
- If for any reason your child will be leaving during the school year, we require an additional 3 month's tuition for the Toddler Class, 10 month's tuition for Primary Class
- **A \$15 fee will be charged per check and/or credit card transaction that fail to process successfully.**
- If (G-d Forbid) an emergency occurs The Jewish Montessori will make every possible effort to contact the listed child(ren)'s parents/guardians or designated emergency contact person.
- If none of the listed contacts can be reached, Parents/Guardians' signatures authorizes The Jewish Montessori personnel to take any appropriate and necessary measures needed for the safety and care of listed child(ren) on this form.
- Parents/Guardians' signatures is acceptance that The Jewish Montessori, Chabad of South La Cienega/Chabad SOLA and their employees assume no liability or responsibility in relation to emergency transportation/services, medical/physician care, exams, tests, treatment or any associated costs.
- Parents/Guardians' signatures grants, without exception, The Jewish Montessori the legal right to use, free of any charge or fee, all photos, videos or other media of the child(ren)'s involvement in school activities.
- Parents/Guardians' signatures below grants permission for listed child(ren) to use all playground equipment and participate in all school activities.

AGREEMENT FOR BINDING ARBITRATION (DIN TORAH)

The undersigned agree that any and all claims, in law or equity, that arise out of or are related to any educational or other services provided to the undersigned or to anyone at the request of the undersigned by The Jewish Montessori New Learning Center and Chabad of South La Cienega / Chabad SOLA against any or all of them or their respective officers, directors, employees and agents shall be decided only by hearing and binding adjudication by a Beis Din of three arbitrators in accordance with substantive and procedural Jewish law as interpreted by the arbitrators. The binding arbitration shall be administered by the Central Committee of Chabad-Lubavitch Rabbis in the United States and Canada. Each party shall select one arbitrator and the two party-selected arbitrators shall select the third arbitrator. The arbitrators shall all be Chabad-ordained Rabbis who are recognized by the Central Committee of Chabad-Lubavitch Rabbis in the United States and Canada to conduct arbitrations under its administration. Each arbitrator is entitled to one vote of equal weight on any decision, ruling, or award in the binding arbitration proceedings. The place of the binding arbitration proceedings shall be at a mutually convenient location in the United States chosen by the majority of the arbitrators. An award rendered by the Beis Din is final, binding, conclusive, and enforceable only if it is in writing and has been signed and dated by a majority of arbitrators and only if it is accompanied by an English translation that is in writing and has been signed and dated by a majority of arbitrators. The award shall be confirmed only in the Los Angeles Superior Court and a judgment may be entered in conformity therewith. Time is of the essence of each provision of this agreement.

In agreeing to this arbitration provision, The Jewish Montessori New Learning Center, Chabad of South La Cienega / Chabad SOLA, and the undersigned give up, waive, and relinquish the following:

- I. Any and all rights they may possess to have such disputes decided in a court trial or jury trial;
- II. Any and all rights of appeal from (1) the award of the Beis Din; (2) any order of the Los Angeles Superior Court, including any order confirming or vacating the binding award; and (3) any judgment of the Los Angeles Superior Court entered in conformity therewith; and
- III. Any and all rights to have such disputes decided by any other civil or religious court wherever situated.

By signing below, the undersigned confirms that he/she has read and understands these provisions and voluntarily agrees to binding arbitration before a Beis Din. As clearly stated in the Code of Jewish Law (Choshen Mishpat 26:1) any and all disputes amongst Jews, monetary or otherwise, must be decided by a Beis Din and not a secular court. Although the undersigned recognizes that this arbitration provision cannot bind a child to arbitration, as an observant Jew the undersigned recognized a religious obligation to do everything in his or her power to submit any claims made by his or her child or children who are students to the same Beis Din proceedings described herein. Accordingly, by signing below, the undersigned voluntarily gives up important constitutional rights to trial by judge or by jury, as well as the right to appeal. The undersigned is advised that (he)(she) has the right to have independent counsel review this agreement prior to signing. Nothing in this agreement shall provide for any legal rights or obligations not expressly provided for.
